2022 Registration

The registration process for the 2022 National Senior Games presented by Humana includes a Priority Registration Period for qualified athletes followed by an Open Registration Period to accommodate athletes age 50+ as of December 31, 2021 who are unable to qualify. Registration will be unavailable during the Quiet Registration Period while NSGA prepares for the Open Registration Period.

Athletes who qualified at a 2020 State Qualifying Senior Games or through the Adjusted Qualification Process adopted in response to the pandemic are eligible to register when the Priority Registration Period begins.

Athletes who first qualify in 2021 at a State Qualifying Senior Games will be eligible to register after the respective sport/event results are verified by NSGA. Status of 2021 sport/event results can be found at [NSGA.com](https://www.nsga.com) on the Registration webpage.

Registration may be limited for some sports/events and could reach capacity at any point during the Priority Registration Period or the Open Registration Period. If a sport/event reaches registration capacity an athlete can add their name to a waiting list which will be time-stamped. Should a space become available athletes on the waiting list will be contacted in chronological order and will be given a brief timeframe to accept the opening and to register for the sport/event. NSGA is unable to guarantee entry into sports/events that reach registration capacity.

Entry forms for the Open Registration Period that are mailed-in during the Priority Registration Period will be processed after Priority Registration closes. During both the Priority Registration and the Open Registration Periods if a sport/event reaches registration capacity prior to processing a mailed-in form, the athlete will be notified that the sport/event is full and placed on the waiting list for the sport/event.

Deadline

For the early registration discount, registrations must be completed online or postmarked by Wednesday, January 26, 2022, 11:59PM Eastern Time.

All Registrations must be completed online or postmarked by Tuesday, March 1, 2022, 11:59PM Eastern Time.

Teams: It is the team captain's responsibility to submit the proper team fees in one payment. Rosters must be finalized by Tuesday, March 1, 2022. Roster changes must be reported to the NSGA no later than Tuesday, March 1, 2022.

Mail-In Processing Fee

Partners

Teams

- The team captain of your qualifying team is the only one who can register your team and must register first.
- Once your team is registered, team members must still register themselves and are subject to the one time non-refundable 2022 National Senior Games \$12 processing fee. (see processing fee)
- After the captain has registered the team, the captain can view the team members by signing back into the athlete portal.
- Captain's must submit all changes and finalize rosters no later than Tuesday, March 1, 2022.

Individual/Team Processing Fee

Regardless if you are an individual athlete or a team member you will need to login and register, or fill out a paper form and pay a \$12 non-refundable processing fee. It is a one-time 2022 National Senior Games fee no matter how many sports/events or changes are made to your registration.

Refunds

Refunds are available with no explanation minus a \$30 administration fee until Tuesday, March 1, 2022. The one-time 2022 processing fee is non-refundable. No refunds after Tuesday, March 1, 2022. In the event that the National Senior Games are canceled, all athletes will receive a full refund of registration fees minus the non-refundable, \$12 processing fee to cover costs incurred with the online registration system and credit card transaction fees.

2022 NSGA Results Book

NSGA will produce a digital Results Book to commemorate the 2022 National Senior Games presented by Humana. The digital Results Book will be available for download from the NSGA website in the Fall of 2022. Registered athletes for the 2022 Games will be sent an email notification when the 2022 Results Book is posted online and available to view and download.
